

## PUBLIC NOTICE OF LIQUIDATION

**Attention:** All persons interested in **National Attorneys' Title Assurance Fund, Inc.** ("NATAF"), an Indiana title insurance company, including holders of its title insurance policies, and all other persons who may have a claim against NATAF; NATAF's former officers and directors; any corporation affiliated with NATAF; producers of NATAF; parties or their counsel of record in pending or threatened litigation and claims involving NATAF; creditors of NATAF; and any banks or other financial institutions that do business with NATAF.

**PLEASE READ THIS NOTICE CAREFULLY. IT DESCRIBES IMPORTANT RIGHTS YOU OR YOUR ORGANIZATION MIGHT HAVE AND WHERE YOU CAN OBTAIN ADDITIONAL INFORMATION CONCERNING NATAF AND YOUR POTENTIAL RIGHTS IN CONNECTION WITH ITS LIQUIDATION.**

On August 20, 2015, the Marion Circuit Court located in Indianapolis, Indiana ("Liquidation Court") entered a final order of liquidation against NATAF ("Order of Liquidation"). The Order of Liquidation declared that NATAF is insolvent, terminated the rehabilitation proceeding that was then pending against NATAF, and appointed the Indiana Insurance Commissioner and his successors in office as liquidator of NATAF ("Liquidator"). The Liquidation Court directed the Liquidator to take possession of the assets of NATAF and to administer them under the Liquidation Court's supervision. The Liquidator is vested by operation of law with title to all of the property, contracts, and rights of action of NATAF, wherever located.

The Liquidation Court has established **May 1, 2017** as the date after which claims against NATAF will be barred. If NATAF has your current address, you should have received or shortly will receive a separate notice about your policy or your other potential claims against NATAF from the Liquidator, or from your title insurance agent.

No action at law or equity may be brought against NATAF or the Liquidator, whether in Indiana or elsewhere, nor shall any existing actions be maintained or further presented, pursuant to Ind. Code 27-9-3-12. **All claims against NATAF must be asserted by filing a Proof of Claim in the liquidation proceeding.** A Proof of Claim Form can be obtained at <http://www.in.gov/idoi/2608.htm> under "Legal Matters."
