The Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) have completed our review of the documents necessary to make an air quality conformity finding on the Northeastern Indiana Regional Coordinating Council (NIRCC's) FY 2013-2016 Transportation Improvement Program (TIP).
