We have reviewed the State Transportation Improvement Program (STIP) amendment request you submitted via correspondence dated July 23, 2018. This request adds projects pursuant to changes made to the Transportation Improvement Program (TIP) for the:

- Northwest Indiana Regional Planning Commission (NIRPC)
- Michiana Area Council of Governments (MACOG)
- Columbus Area Metropolitan Planning Organization (CAMPO)
- Northeastern Indiana Regional Coordinating Council (NIRCC)
- The Area Plan Commission of Tippecanoe County (TCAPC)
