## **Everton Water Corp. rate case: Consumer comments invited**

If you would like to comment on Everton Water Corporation's proposed rate increase, here's your chance.

The Indiana Office of Utility Consumer Counselor (OUCC) is inviting written consumer comments on the request through April 21, 2016. The OUCC, the state agency representing consumer interests in cases before the Indiana Utility Regulatory Commission (IURC), anticipates filing its report in this case on April 28, 2016.

Everton Water Corp. is a not-for-profit utility serving about 750 customers in Fayette and Union Counties. If approved, its pending proposal would raise the monthly water bill for a residential customer using 5,000 gallons from \$33.70 to \$42.85. The utility's current rates were approved in 2007. In its filing with the IURC, Everton Water Corp. states that the increase would cover operating and maintenance costs along with costs in its three-year capital improvement plan (which includes new equipment, treatment plant and office projects, and meter replacements).

The OUCC needs to receive all written consumer comments no later than April 21, 2016 so that it can: 1) Consider them in preparing its report and 2) File them with the Commission to be included in the case's formal evidentiary record. Comments should include the consumer's **name**, **mailing address**, and a reference to "**IURC Cause No. 44744-U.**"

Everton Water Corp. is seeking the rate increase through the state's Small Utility Filing Procedure, which is available to utilities with fewer than 5,000 customers and is designed to reduce the time and expense involved with regulatory filings. Savings are gained by allowing utility staff to use standardized forms and the utility's resulting need for less assistance from rate consultants or attorneys.

The standard for OUCC and IURC reviews on small utility filings is the same that applies to traditional utility filings. The OUCC conducts its review on behalf of all utility consumers while the IURC's review is conducted on behalf of the public interest (a balancing of utility and customer interests). A settlement agreement is possible in any legal proceeding; such an agreement, if reached, would require IURC approval.
