Ms. Frye stated that the Agency has looked into installing audio and visual equipment in the board room so that the audience and public would be able to hear the meetings as well as watch the meetings via computer. #### **Lt. Craig McCartt, Homicide Unit, Indianapolis Metropolitan Police Department – Pharmacy Robberies, Indianapolis Area:**

Lt. McCartt informed the Board that in 2014 they saw a large increase in pharmacy robberies. In 2014 there were 78 robberies.

In 2015 there was an increase of 113% in pharmacy robberies just in the IMPD service area with a total of 166 pharmacy robberies in this area.

In 2016 there were 55 pharmacy robberies in the Indianapolis area. Indiana was rated second highest in pharmacy robberies.

Pharmacy robberies seem to be decreasing in 2017, to date the IMPD area has had 10 pharmacy robberies and this includes attempted robberies. The entire state is currently at 19 pharmacy robberies.

**Carol Ott, PharmD, BCPP, Clinical professor of Pharmacy Practice, Clinical Pharmacy Specialists, Psychiatry, Eskenazi Health/Midtown Community Mental Health, Purdue University College of Pharmacy, Research Presentation regarding Gabapentin use:**

Ms. Ott stated that Gabapentin has become an issue over the last seven (7) to eight (8) years.

Ohio requires it to be reported to their PDMP program.

Virginia legislature passed a law to require it to be reported to their PDMP program

Kentucky made is a schedule V drug.

Gabapentin: Indicators of Misuse:

- A study in the US found that 22% of 162 study participants with opioid use disorder had a prescription for gabapentin
- Of these, 40%, used higher than prescribed doses
- Gabapentin has been found in 1% of drug-related deaths in Scotland
- Cross-sectional studies of opioid abuse in UK and US samples found gabapentin misuse to be 15% - 22% of the sample
- "Street market" demand for gabapentin for misuse of the drug itself and as a cutting agent for heroin
- Street market" price - \$1.00 - \$7.00 per table depending on dose
- Increase ER visits by 90% since 2008 (Drug Abuse Warning Network)

Systematic Review (2017):

- Gabapentin abuse has been studied in 23 epidemiologic studies since 2010
- More prevalent in past or current opioid abusers (1.1%) and in those with an opioid use disorder (15% - 22%)
- Poison center data in 2014 noted 116 overdose cases reported, usually co-ingestion with other substances
- 2 fatal overdoses were with gabapentin alone – highest reported overdoses were 11,500 mg and 91,000 mg

- One study of prison inmates with psychiatric diagnoses and substance use disorder suggested 16% rate of gabapentin misuse

Research Goals:

- Reduce the number of people who start using an addictive substance
- Reduce the number of persons who become addicted to a legally prescribed substance
- Develop prescriptive guidelines for hospitals and policymakers to reduce over prescription practices in Indiana.

Research Approach:

- Prior studies on inappropriate prescribing investigate the effects of policy implementation on individual clinics or specialties (Meeker et al. 2016, 2014)
- To truly understand the phenomenon of over prescription, internal and external factors, along with their interaction, must be examined – systems approach
- Systems approach requires comprehensive dataset incorporating both internal and external variables associated with over prescription.
- Define baseline prescription rates in Indiana using methods established by prior literature (Paulozzi et al. 2011, Gammaitoni et al. 2003)
- Calculate over prescription relative to baseline rates while controlling for changes in temporal and socioeconomic factors
- Analytically examine characteristics associated with over prescription in Indiana
  - Prescribers – clinical experience, specialty
  - Hospitals – clinical technology systems, teaching intensity, MD workload
  - Legislation – value based purchasing program, open payments database

Ms. Slusser informed the Board that she attended a meeting in Washington D.C. on September 5<sup>th</sup> organized by the Regional Judicial Opioid Initiative. Select PDMP Administrators met with representatives from Health and Human services and child protective services to discuss the possibility of using PDMP data in CPS cases.

She also attended the Harold Rogers PDMP National meeting on September 6<sup>th</sup> - 8<sup>th</sup> and the following were the topics of discussion:

- Adding diagnosis codes to opioid prescriptions
- Treatment facilities using the PDMP at intake
- State/Federal collaboration
- Additional grant funding opportunities

The PLA 151 working group has been established and they are looking at having their first meeting this month.

On August 31, 2017, PLA was informed that we had been awarded the additional grant funding that was applied for in July. Grant funds will be used to establish a CE program

for coroners and enhance and maximize the PDMP by focusing on integrating our healthcare facilities.

#### Statewide Integration:

- On August 24<sup>th</sup>, Governor Holcomb made an announcement at the Indiana Commission to Combat Drug Abuse meeting. The PLA has entered into an agreement with Apriss Health to provide INSPECT integration to all qualified healthcare entities across Indiana at no cost to the facilities. This project will be a three (3) year phased in approach, funded using a combination of grant money and CSR funds. The PLA currently has a two (2) year agreement with Apriss and the option to renew for an additional two (2) years at the agreed upon price.
- An integration request form, on-boarding instructions and an end user license agreement have been placed on the INSPECT page.
- They has submitted a list of priority facilities to Apriss and are actively pursuing integration with large hospitals and pharmacy chains.

#### Partnership Opportunities:

- Early integration partnerships include Meijer pharmacies, IU Health, Eskenazi, Community Health and Franciscan Alliance
- CVS Pharmacy reached out to them last week to discuss integration. They are currently updating their pharmacy management system, which will be done in November. Her goal is to have an end user license agreement signed by CVS in time to get the integrated by the November date.

#### AWARxE Update:

- Mass emails have been sent out to all INSPECT users letting them know that they are switching to the AWARxE system and they will need to reregister for their account soon. Reminders will be sent after the AWARxE launch and leading up to the deadline to reregister.

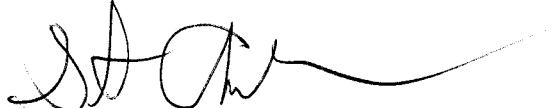
